The bidders may submit their quotation along with EMD as applicable by way of Demand Draft in favour of Director, LGBRIMH, Tezpur

The quotation received in time will be opened at LGBRIMH, Tezpur. The Bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations.

The auction will be governed by the following conditions:

- (i) Prospective bidder may inspect the vehicles from 06.07.2018 to 20.07.2018 at LGBRIMH from 10 AM to 5 PM.
- (ii) The successful bidder will be required to deposit the balance bid amount after deducting earnest money within one week of intimation about successful bidder by way of Demand draft in favour of Director, LGBRIMH.
- (iii) The vehicles will be disposed off on an "as is where is basis" and no guarantee for its worthiness or quality will be given by LGBRIMH.
- (iv) The delivery of the vehicle will be given only after the successful bidder submits documentary evidence in support of residential status (Voter Identity card/ Adhar card in case of individual and GST Certificate in case of firms etc) and payment of remaining balance amount.
- (v) The vehicle shall have to be removed by the successful bidder within 7 days at his own expenses, failing which, the EMD amount will be forfeited and the auction will stand cancel.
- (vi) The successful bidder will also be responsible for getting the Registration certificate of the vehicle transferred in his name at his own cost expeditiously. LGBRIMH will not be responsible for any lapse on his part in this regard and will not be liable for any misshape/accident or for any loss/damage after delivery of the vehicle.
- (vii) The successful bidder shall not be allowed to withdraw his bid. Withdrawal will invite forfeiture of EMD.
- (viii) The Director ,LGBRIMH reserves the right to accept or reject any or all of the quotation without assigning any reason.
- (ix) Price quoted by the bidder should not be less than the reserved price fixed for the vehicle by the authority.
- (x) The intending bidder shall have to deposit the entire sale value including GST as applicable in advance within 3 (three) days from the date of auction to the undersigned before lifting the condemned vehicle at his own risk else his/their earnest money will be forfeited.
