**WHEREAS** in response to the notification No. LGB/NAZ/..... Dated ...... Dated ...... The bidder has submitted to the LGBRIMH a tender a supply of medicine specified there in the Annexure I subject to the terms & conditions contained in the said tender.

**AND WHEREAS** the bidder has also deposited with the Government a sum of Rs. ...... as performance security for the execution of an agreement undertaking the due fulfillments of the contract, in case this tender is accepted by LGBRIMH.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

**1.** The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

a) The Letter of Award of contract and supply order issued by the purchaser

- b) The Notice Inviting Tender
- c) The supplier's bid including enclosures, annexure, etc.
- d) The Terms and Conditions of the Contract
- e) The Schedule of Requirement

f) The Technical Specification

g) Any other document listed in the supplier's bid and replies to queries, clarifications issued by the purchaser, such confirmations given by the bidder which are acceptable to the purchaser and the entire Addendum issued as forming part of the contract.

2. In case the bidder fails to execute the agreement as aforesaid incorporating the terms and conditions governing the contract, the purchaser shall has the power and authority to recover from the supplier any loss or damage caused to LGBRIMH by such breach as may be determine by LGBRIMH by appropriating the security money deposited by the supplier and take appropriate action as per penalty clause of the tender.
