No. 1 to 3: (i) A recognized MBBS degree qualification included in the First or Second Schedule or Part-II or the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956(102 of 1956). Holders of educational qualifications included in Part-II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956(102 of 1956). (ii) Post-graduate degree in the concerned speciality or Super speciality mentioned in Section –A of Schedule-VI or equivalent recognized DNB qualification awarded by National Board of Examination.

Essential Experience for Sl. No. 1to 3: (Super Speciality and other than Superspecialty):

At least three years teaching experience as Senior Resident/ Demonstrator/Registrar/ Lecturer in the concerned Specialty or Super-speciality in a recognized teaching institution after obtaining the first post graduate degree.

Essential Qualification for Sl.No. 4 & 5: (i) Master's Degree in Social Work /Psychology (ii) M.Phil in Psychiatric Social Work/Clinical Psychology or equivalent qualification from a recognized Institution. (iii)Ph. D in Psychiatric Social Work/Clinical Psychology from a recognized Institution/ University.

Essential Experience for Sl.No. 4 & 5: 3 years teaching /clinical /research experience in the concerned subject after Ph.D degree.

Essential Qualification for Sl. No. 6: (i) Master's Degree in Psychiatric Nursing (ii) Ph. D in Psychiatric Nursing from a recognized Institution/ University.

Essential Experience for Sl. No. 6: 3 years teaching /clinical /research experience in the concerned subject after Ph.D degree.

- Note 1: Doctorate of Medicine (DM) or Magister Chirurgiae (M. Ch.) qualification of three years' duration shall be counted towards requirement of teaching experience.
