**Essential Qualification for Sl. No. 01 to 03:** (i) A recognized MBBS degree qualification included in the First or Second Schedule or Part-II or the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956(102 of 1956). Holders of educational qualifications included in Part-II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956. (ii) Post-graduate degree in the concerned speciality or

Super speciality mentioned in Section –A of Schedule-VI or equivalent recognized DNB qualification awarded by National Board of Examination.

**Essential Experience for Sl. No. 1 to 3:** At least 1 year experience (for Pay level L-11) / 3 years experience (for Pay level L-12) as Lecturer/Tutor/ Registrar/ Demonstrator/ Senior Resident/in the concerned Specialty or Super-speciality in a recognized teaching institution after obtaining the first post graduate degree.

**Essential Qualification For Sl. No. 4 to 6:** (i) I and II class (55%) in Masters Degree in Social Work/Psychiatric Nursing /Clinical Psychology. (ii) M. Phil in Psychiatric Social Work/Clinical Psychology or equivalent qualification from a recognized Institution. (iii) Ph.D in PSW/Clinical Psychology/Psychiatric Nursing from a recognized Institution/University.

**Essential Experience for Sl. No. 4 to 6:** No experience (for pay level L-10) Or At least one year teaching /clinical/research experience in the concerned subject after Ph.D. (for Pay level L-11) Or At least 3 years of teaching/clinical/research experience in the concerned subject after Ph.D. (for pay level L-12).

**Note 1 :-** Doctorate of Medicine (DM) or Magister Chirurgiae (M. Ch.) qualification of three years' duration shall be counted towards requirement of teaching experience.

**Note 2 :-** Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) qualification of five years' duration, shall be taken as three years for completion of post graduate and the two years of the said Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) shall be counted towards requirement of teaching experience.

**Note 3:** Teaching experience in any other post like the post of General Duty Medical Officer/Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.

**Abbreviation used:** Unreserved (UR), Other Backward Classes (OBC), Schedule Caste (SC), Scheduled Tribe (ST), Person with Benchmark Disability (PwBD), S- sitting ,ST-standing, KC – kneeling and crouching, MF- Manipulation with fingers ,SE- seeing, C- communication. Terms and conditions for all reserved categories including PwBD will be as per GOI norms.

### **Terms & Conditions For Contract Appointment For the above mentioned posts**

1. The appointment is purely on full time **CONTRACT BASIS for a period of 03 months** with effect from the date of joining which may be further extended as per requirement of the Institute; or till such time the regular arrangements are being made, whichever is earlier. If the contract is not extended further, the same will lapse automatically. The appointment may be terminated at any time, giving one month's notice or by paying one month's salary by the appointee or failure to complete the period of three months to the satisfaction of competent authority. However, the Competent Authority reserves the right to terminate forthwith without assigning any reason thereof.
2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when

- required. No extra/additional allowances will be admissible in case of such assignment.
3. The appointee shall not be entitled to any other benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
  4. The appointee shall not have any claim or rights for regular appointment to any post at LGBRIMH.
  5. The appointee shall be on the whole time appointment of the LGBRIMH and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
  6. Other terms and conditions of service which are not specifically mentioned herein will be governed by relevant rules and orders issued from time to time.
  7. Interview will be through hybrid mode. For Registration eligible candidates are requested to e-mail necessary documents (all relevant original testimonials/BIO-DATA, attested copies of certificate/ one PP size photograph) to institute e.mail id lgbrimhrecruitment@gmail.com
  8. If any declaration given or information furnished by him/her proves to be false or if he /she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
  9. Canvassing in any form will be disqualified for being selected.
  10. LGBRIMH reserves the right to increase or decrease the number of vacancies.
  11. The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard.

  13. Crucial date for determination of eligibility with reference to age, qualification, experience, caste certificate etc. and all other terms and conditions will be the date of walk-in-interview.
  14. The selected candidates are to join the post at LGBRIMH immediately, after further communication of offer of appointment.
