NOTIFICATION FOR CONTRACTUAL RECRUITMENT
(Under Addiction Treatment Facility - ATF Scheme)

Walk-in-interview will be held for the under-mentioned **contractual posts** under the Addiction Treatment Facility (ATF) Scheme for a period of one (1) year on **12.08.2026** from 10:00 AM onwards at the MS Conference Room, Administrative Building, LGBRIMH, Tezpur-784001.

Educational Qualifications:

Sl. No. 1 (Medical Officer): MBBS from a recognized Institute. Preference will be given to candidates possessing MD or equivalent qualification in Psychiatry.

Sl. No. 2 (Staff Nurse): ANM (Auxiliary Nurse Midwife). Preference will be given to GNM or B.Sc. Nursing candidates.

Sl. No. 3 (Counsellor): Graduate in Psychology / Social Work / Sociology. Preference will be given to candidates with Master's degree in the concerned discipline.

TERMS AND CONDITIONS:

1. The engagement is offered on a full-time contract basis for a fixed term of one (1) year, effective from the date of joining. This term is contingent upon the continued availability of funds under the ATF Scheme. The contract shall expire upon completion of one year or cessation of funding, whichever is earlier. Renewal is discretionary and subject to the provisions of the ATF Scheme. If not renewed, the contract shall expire automatically. The contract may be terminated by either party by serving a one-month notice or by remitting a sum equivalent to one month's salary. Notwithstanding

the above, the Competent Authority retains the absolute right to terminate the engagement immediately, without prior notice or cause, at any stage of the tenure.

2. The appointee shall not have any claim or right for regular appointment to any post at LGBRIMH.
3. The appointee shall carry out the duties assigned by the competent authority, who reserves the discretion to assign additional tasks as required. No extra allowances shall be admissible for such assignments.
4. The appointee shall not be entitled to any benefits such as Provident Fund, Pension, Gratuity, Medical Attendance/Treatment, Seniority, Promotion, or any other benefits available to regularly appointed Government servants.
5. Prescribed qualification is the minimum requirement. Mere possession of the prescribed qualification does not entitle any candidate for selection or interview call.
6. The decision of the Selection Committee at LGBRIMH, Tezpur, regarding selection of candidates shall be final. No representation in this regard shall be entertained.
7. No travelling or other allowances shall be paid to candidates for attending the interview or for joining the post.
8. Work and conduct of the appointee shall be reviewed periodically. If found unsatisfactory or unsuitable, the engagement shall be terminated immediately without any notice.
9. The candidate is expected to conform to the rules of conduct and discipline applicable to Institute employees.
10. The candidate should not have been convicted by any Court of Law.
11. No allowance or facility other than the consolidated remuneration/ emoluments/ salary shall be admissible.
12. Applicants already working elsewhere must produce a Relieving Certificate from their present employer before joining the Institute.
13. If any information or declaration given by the candidate is found to be false, or if the candidate has willfully suppressed any material information relevant to the appointment, he/she shall be liable to be removed from service immediately at any stage, and appropriate action shall be taken by the Appointing Authority as deemed fit.
14. The remuneration shall be a fixed consolidated pay.
15. Other terms and conditions of service not specifically mentioned herein shall be governed by the relevant rules and orders issued by the Institute from time to time.
